

Change of Registrant Agreement

1. Overview

This Change of Registrant Agreement (“Agreement”) is entered into between Atak Domain Bilgi Teknolojileri A.Ş. (“Atak Domain”) and the individual or legal entity (“User”) who accepts this Agreement electronically. The Agreement becomes effective at the moment of electronic acceptance.

This Agreement governs the terms and conditions of the “Change of Registrant” service (“Service”) provided by Atak Domain for the purpose of transferring a domain name from the current registrant (“Current Registrant”) to the new registrant (“New Registrant”). The Agreement applies to both the Current Registrant and the New Registrant.

By approving this Agreement, the party declares that they have read, understood, and accepted:

- This Agreement,
- Atak Domain’s General Service Terms,
- Domain Registration Agreement,
- Uniform Domain Name Dispute Resolution Policy (UDRP),
- ICANN Inter-Registrar Transfer Policy – Part C (IRTP-C).

Atak Domain operates as a domain registrar working with an ICANN-accredited registry operator. Atak Domain reserves the right to amend this Agreement in order to comply with rules set by ICANN and relevant top-level domain (TLD/ccTLD) registry operators.

Any updates to this Agreement become effective upon publication on the Atak Domain website. Continued use of the Service constitutes acceptance of the updated Agreement.

2. Change of Registrant Process and Atak Domain’s Role

The Current Registrant and the New Registrant declare that they perform this process of their own free will.

Atak Domain’s role is limited to:

- Technically processing the transaction,
- Implementing ICANN transfer policies,
- Providing the electronic approval workflow.

Process:

1. The Current Registrant initiates the change request through the control panel.
2. Atak Domain sends a confirmation e-mail to the New Registrant.
3. The New Registrant must log in to their account and confirm the request within 10 days.
4. If the request is not approved within 10 days:
 - o The process is canceled,
 - o The transaction ID and security code become invalid,
 - o The process must be restarted.
5. Once the change is completed, Atak Domain notifies the Current Registrant via e-mail.
6. The Current Registrant may object to this notification within 15 days.

The Current Registrant fully releases Atak Domain from all consequences of an incorrect or unauthorized change of registrant.

3. Transfer Lock (60-Day Rule)

Under ICANN IRTP-C:

- After a change of registrant is completed, the domain name cannot be transferred to another registrar for 60 days.
- If the parties intend to transfer the domain to another registrar within 60 days:
 - The registrar transfer must be performed first, then the change of registrant.
- If another change of registrant occurs within the 60-day period, the period restarts.

This rule is mandated by ICANN and cannot be waived by Atak Domain.

4. Representations and Warranties

Representatives of the Current Registrant and the New Registrant hereby affirm that:

- They are authorized to perform the change of registrant,
- They have not transferred the rights to the domain name to any third party,
- They will fulfill all obligations set forth in this Agreement.

5. Successors and Assigns

This Agreement is binding upon the parties and their successors, assignees, and authorized representatives.

6. Waiver and Release

The Current Registrant agrees that:

- They have no refund, fee, or rights claim against Atak Domain under any agreement,
- They will not request any obligation from Atak Domain after the change of registrant,
- They fully release Atak Domain from all liabilities.

7. Limitation of Liability of Atak Domain

The New Registrant acknowledges that they are fully responsible for:

- The Current Registrant's authority to transfer the domain name,
- Any past legal disputes,
- All risks arising from the use of the domain name,
- Any situations that may delay or prevent completion of the change process,
- The validity of ownership of the domain name.

Both parties acknowledge that Atak Domain shall not, under any circumstance, be held liable for:


- Suspension, deletion, or modification of the domain name,
- Inability to use the domain name or related services,
- Access interruptions, data loss, transmission errors,
- Enforcement of ICANN policies.
