

DOMAIN REGISTRATION AGREEMENT

1. General ProvisionsC

This Domain Registration Agreement (“Agreement”) is entered into electronically between you (“User”, “customer”) and Atak Domain Bilgi Teknolojileri Anonim Şirketi (“Atak Domain”, “we”, “us”, “our”). The Agreement becomes effective on the date of electronic acceptance.

This Agreement sets forth the terms and conditions governing the use of all domain registration, renewal, transfer, and related services provided by Atak Domain.

The terms we, us, and our refer to Atak Domain. The terms you, your, user, and customer refer to the individual or legal entity accepting this Agreement.

Unless expressly stated otherwise, this Agreement does not grant rights or benefits to any third party.

By accepting this Agreement, you also acknowledge and agree that:

- (1) Atak Domain may modify this Agreement, its policies, or related contracts at any time. Changes become effective upon publication.
- (2) Continued use of the Site or Services after changes are made constitutes acceptance of the updated version.
- (3) Atak Domain may occasionally send change notifications via e-mail. It is your responsibility to keep your account information, especially your e-mail address, up to date. Atak Domain is not responsible for failure to receive notices due to invalid or outdated contact information.

Atak Domain is an ICANN-accredited domain registrar. All ICANN rules form an integral part of this Agreement. Additionally, each TLD or ccTLD Registry Operator’s terms, registration policies, and technical requirements are incorporated into this Agreement and may change over time.

The term “Registration Service Provider” refers to the service provider managing registration services on behalf of the Registry Operator for the relevant TLD or ccTLD.

2. General Provisions for All Registrations

Unless otherwise stated, this section applies to all TLD and ccTLD registrations.

2.1 Registration Policies

By registering a domain name, you agree to comply with all Registration Policies of the relevant TLD.

The Registry Operator of the TLD is a recognized third-party beneficiary of this Agreement.

You acknowledge that the Registry Operator has rights arising from this Agreement and that such rights do not terminate with the cancellation of this Agreement.

2.2 Registration Requirements

By submitting a registration or renewal request, you represent and warrant that:

All information you provide is accurate, complete, and not misleading.

You will provide supporting documents if required.

You will continue to meet the eligibility criteria of the relevant TLD during the entire registration period.

If you previously applied for the same domain with another registrar and were rejected due to eligibility, you must disclose this.

Even if your application is accepted, you acknowledge that third parties may have superior rights.

Providing false, incomplete, or misleading information may result in cancellation of the registration.

2.3 Prohibition of Misleading Content, Trademark Violations, and Impersonation

You may not use any registered domain name for activities including but not limited to:

Trademark infringement

Trade name impersonation

Fraud

Identity forgery

Phishing

Impersonation of individuals or organizations

Atak Domain reserves the right to suspend, cancel, or report the domain name to authorities in such cases.

2.4 Ownership

Domain registration does not grant ownership; it grants a time-limited usage right.

A domain name may not be:

Used as collateral

Pledged

Transferred as property

2.5 ICANN Requirements

All users are subject to current ICANN policies including:

RAA 2013
WHOIS/RDDS Policies
UDRP
URS
Data Validation Requirements

Atak Domain may modify this Agreement to ensure compliance with these policies.

2.6 Indemnification

You agree to indemnify the Registry Operator, Atak Domain, and related parties for any claims arising from your domain registration or use.

3. Registration and Payment Terms

All fees are listed on www.atakdomain.com/domain-fiyatlari. Atak Domain reserves the right to modify prices.

3.1 Domain Renewal Terms

Renewals are non-refundable.

If payment cannot be collected, the domain will expire.

Certain ccTLDs (.de, .eu, .uk, etc.) require renewal before the deadline.

Expired domains may enter the following stages:

Grace Period

Redemption Period

Pending Delete

If you do not renew a domain, Atak Domain may choose to renew it at its own discretion. Restoration fees apply as published.

3.2 Free Product Terms

Free products provided with domains may only be used while the domain is active.

Free domains cannot be transferred or have account changes during the first 5 days.

If the registration fails, the free domain may also be cancelled.

3.3 Agreement Term and Transfers

A domain cannot be transferred during the first 60 days after registration.

WHOIS changes may trigger a transfer lock under ICANN policy.

Transfers may be blocked in cases of suspected fraud or payment disputes.

Domain testing is prohibited. Atak Domain may refuse refunds or charge additional fees for such cases.

3.4 Obligation to Update Information

If any information provided changes, it must be updated within 5 business days.

Providing inaccurate information may result in suspension of the domain.

Correct WHOIS information must be provided and verified when required.

Your data may be published through WHOIS as required by ICANN.

3.5 WHOIS-Published Information

The following may be published:

Domain name

Your name and address

Phone and email

Nameservers

Registration and expiration dates

Registrar information

Atak Domain may publish certain information related to domain sales (domain name, price, transaction time).

3.6 Data Sharing and Retention

Your domain-related data may be shared with:

Registry Operators

ICANN

UDRP/URS dispute resolution providers

Authorized governmental bodies

Atak Domain states that data will be protected with reasonable security measures.

4. Your Responsibilities and Suspension of Services

You represent that your use of the domain name will not infringe upon the rights of any third party.

Domains may be suspended in cases of illegal activity.

Atak Domain complies with UDRP/URS decisions, court orders, ICANN policies, and official

authority notifications.

You may not hold Atak Domain liable for any resulting damages.

4.1 Fraud Suspicion

In cases of serious violations such as fraud, phishing, or identity theft, Atak Domain may suspend the domain without notice.

4.2 Atak Domain's Right to Refuse and Delete

Atak Domain may refuse a registration or delete a domain in cases including:

- Non-compliance with ICANN rules
- Misleading WHOIS information
- Non-payment
- Official authority requests
- Server or infrastructure security risks
- Spam, malware, or abuse

Refunds will not be issued for cancelled services.

5. Service Restrictions

Domains may be disabled if traffic, spam, DDoS, or abuse threatens Atak Domain's infrastructure.

Atak Domain reserves the right to delete any domain registration within the first 30 days. No refunds are issued for morally inappropriate, spam-related, or gambling-related domains.
