

# UK Domain Name Registration Agreement

(Applicable to .uk, .co.uk, .me.uk and .org.uk domain extensions)

This supplementary agreement covers only the registration and management of domain names ending in .UK, .co.uk, .me.uk and .org.uk. “.UK” is the official two-letter ISO country code for the United Kingdom.

## Preliminary Notice

Atak Domain Bilgi Teknolojileri A.Ş. (“Atak Domain”) operates as a reseller and technical partner of an accredited registrar working directly with Nominet UK, the official registry operator for the .UK top-level domain.

Atak Domain and its resellers (“RSP”) agree to provide registration, renewal, and management services for .UK (.co.uk, .me.uk, .org.uk) domain names on behalf of RSP customers through Atak Domain’s technical infrastructure.

The following provisions apply.

## 1. Registration Requirements

### 1.1

All registry operators, sub-resellers, and end users registering .UK (.co.uk, .me.uk, .org.uk) domain names are required to comply with the terms and conditions established by Nominet UK.

### 1.2

Any customer registering a .UK domain is deemed to have read, understood, and accepted the regulations listed below.

Atak Domain requires its resellers and customers to comply with these regulations.

## 2. Domain Name Dispute Resolution

### 2.1

All rights and usage disputes concerning .UK domain names are resolved under Nominet's Dispute Resolution Service (DRS) Policy.

### 2.3

The Customer acknowledges that decisions issued by Nominet may be directly binding on the registration and management of a .UK domain name.

## 3. Term

### 3.1

.UK (.co.uk, .me.uk, .org.uk) domain registrations and renewals may only be made for periods between 1 and 10 years.

### 3.2

The Customer is solely responsible for tracking the expiration date of the domain name. Failure to renew or delayed payment may result in the domain name being:

- deactivated,
- suspended, or
- deleted.

#### 4.2

All fees are charged in USD. For transactions originating from Türkiye, amounts are converted according to the Turkish Central Bank exchange rate.

#### 4.3

Exchange rate fluctuations, bank commissions, and payment provider fees are the responsibility of the Customer.

#### 4.4

Atak Domain reserves the right to modify pricing and promotional conditions unilaterally by updating its website.

This supplementary agreement forms an integral part of the Atak Domain General Domain Registration Agreement and is applied together with the general terms for all .UK domain names.
