

# Whois Data Reminder Policy

## 1. Purpose and Scope

This Whois Data Reminder Policy (“Policy”) has been prepared to ensure the accuracy and currency of Whois information associated with domain names registered through Atak Domain Bilgi Teknolojileri A.Ş. The Policy complies with the **ICANN Whois Data Reminder Policy (WDRP)** and applies to all gTLD domain names managed by Atak Domain.

## 2. Accuracy of Whois Information

The domain name registrant represents and warrants that all Whois information provided during the registration, renewal, and management of a domain name is accurate, complete, and up to date.

This information includes:

- Administrative, technical, and billing contact details (full name, address, phone number, and email address),
- Registrant (domain owner) contact information.

Providing false or incomplete data may result in the **suspension** or **cancellation** of the domain name pursuant to ICANN policies.

## 3. Annual Whois Reminder Notice

In accordance with ICANN’s WDRP requirements, Atak Domain sends an annual reminder email to all domain registrants. The reminder notice includes:

- A summary of the Whois information currently on file,
- A requirement to review the accuracy of this information,
- Instructions for updating the information if needed,
- A warning regarding the consequences of inaccurate Whois data.

This reminder is sent automatically to the email address associated with the registrant.

## 4. Updating Whois Information

The registrant is required to update their Whois information **within 7 days** of any change. Updates may be made via the Atak Domain customer panel.

Failure to update Whois data or providing false information may lead to:

- Atak Domain contacting the registrant for verification,
- Temporary suspension of the domain name if the data cannot be validated.

## 5. Verification of Contact Information

Under ICANN policies, Atak Domain may request the registrant to verify their contact information in certain circumstances. Verification methods may include:

- Email verification,
- Phone verification,
- Requesting supporting documents such as identification or proof of address.

If verification is not completed, the domain name may be placed on **Registrar Hold / ClientHold**, making it inactive until verification is resolved.

## 6. Responsibilities of Atak Domain

Atak Domain is responsible for:

- Sending annual Whois reminder notices,
- Ensuring compliance with ICANN WDRP requirements,
- Providing support to customers during update or verification processes.

Atak Domain is not responsible for any legal or technical issues arising from the registrant's failure to provide accurate or updated Whois information.

## 7. Responsibilities of the Registrant

The registrant is solely responsible for:

- Keeping Whois information accurate and current,
- Reviewing the annual reminder email upon receipt,
- Updating any incorrect or outdated information promptly.

## 8. Suspension or Cancellation Process

A domain name may be temporarily or permanently suspended or cancelled if:

- Whois information is found to be false or incomplete,
- The registrant fails to respond to requests for updates,
- The registrant does not complete required verification steps.

These actions are mandatory under ICANN regulations.

## 9. Policy Updates

Atak Domain reserves the right to update this Policy as required by changes to ICANN rules or other regulatory requirements. Updates become effective immediately upon publication on our website.
